- 1) (35 points) Suppose your current income is \$200, and next year's income is \$360. How much should you consume each year if the interest rate is 20% and your utility function is  $U(C_0, C_1) = C_0^{1/4}C_1^{1/4}$ ? Show all work.
- 2) (45 points) Suppose your utility function is  $U(H, J, K) = (H*J*K)^{1/4}$ , your budget is \$36, the price of a hat is \$3, the price of a jump rope is \$1/hour, and a kick boxing instructions costs \$2/lesson. You also have a time constraint of jumping rope costing 1 hour and a kick boxing lesson costs 2 hours per lesson. Set up the two constraints and use a Lagrangian to find the equilibrium.
- 3) (10 points) Why do we use a Lagrangian for the Von Stackleberg model, but not the Cournot?
- 3) (5 points) What is the price of this year's consumption in Question #1? Explain your logic.
- 4) (5 points) Why is the Cournot Model now called the Cournot-Nash Model?
