- 3) (15 points) According to the article below, what is the inflation rate in Argentina? The article mentions at least two different interest rates, for one of them, calculate the real interest rate. - 4) (15 points) What is the difference between "saving" and a "savings" account? For each of them, determine if it is a stock or a flow. Explain your logic.

- 6) (20 points) Explain the difference between real GDP and nominal GDP? Which one do we worry about? Why do we worry about that one and not the other one? Give an example in your explanation.
